VET DELIVERY

No need to become an RTO, (Registered Training Organisation). Dance Factory offers the VET Dance program to dance schools with a range of options. The options are non exclusive and at any one point, schools may adopt a range of models that are best suited to the needs of the school community.

To deliver the course at your school you must have:

- adequate dance space and facilities
- a trainer and assessor with a TAE qualification and industry knowledge in the vocation of dance

A dance school can negotiate with Dance Factory to deliver the program, where the school can demonstrate access to suitable staffing, facilities and resources.

All schools will need to provide evidence of AQTF compliance for a program to be auspiced by Dance Factory.

Other delivery: arrangements can be provided at an additional cost. For example Dance Factory can provide teachers and or assessors to the dance school.

If you are unable to deliver the course at your school and have students interested in dance, **Dance Factory also offers the course at their Richmond studios.**

PROGRAM OPTIONS

VET programs are designed to provide a more vocational VCE, linking them to industry needs.

The VET Dance program expands opportunities for senior secondary students as the study will prepare these young people for the workplaces of the future. This is achieved through the provision of nationally recognised training qualifications that have been integrated into the VCE.

All training qualifications are derived from the Australian Qualifications Framework and are either delivered or auspiced by Dance Factory.

ENTRY REQUIREMENTS

There are no pre-requisites to enrol in VET Dance. Previous dance experience is an advantage but not necessary. Due to the physical nature of the course, physical fitness is an important consideration.

Students can commence in Years 10 or 11. Students must complete Units 1 & 2 before commencing 3 & 4 to receive the Certificate. Year 12 students commencing in Units 3 & 4 will receive a Statement of Attainment for units completed.

On successful completion of this program the student will receive:

Credit towards VCE: students will be eligible for up to six units credit towards VCE, 4 units at Unit 1 / 2 level, plus a Units 3 / 4 sequence. Students wishing to receive an ATAR contribution for the Units 3 / 4 sequence in the VCE VET Dance Program must undertake scored assessment for the purpose of achieving a study score. This study score can contribute directly to the ATAR, either as one of the student's best four studies (primary four) or as a fifth or sixth study. Where a student elects not to receive a study score no contribution to the ATAR will be available.

Qualification CUA20120 Certificate II in Dance

Units 1 and 2 in first year of study – partial completion of Certificate II in Dance (Year 10 or 11 students)

Units 3 & 4 in second year of study – complete Certificate II in Dance and partial completion of Certificate III in Dance (Year 11 or 12 students)

Qualification CUA30120 Certificate III in Dance

On completion of Units 3 & 4 (above), students may undertake additional units to complete Certificate III in Dance (Year 12 students)

On completion, students will receive -

- A certificate for CUA20120 Certificate II in Dance
- A statement of attainment for units completed from CUA30120 Certificate III in Dance.
- Recognition of units for credit towards the VCE
- A certificate for CUA30120 Certificate III in Dance (if undertaken)

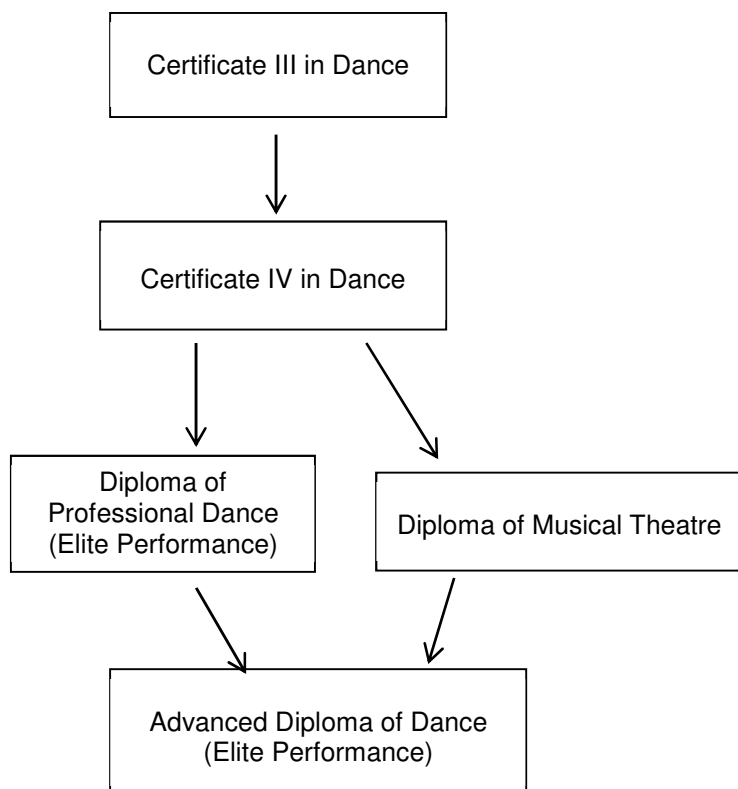
ARTICULATION & PATHWAYS

The *CUA Creative Arts and Cultural Training Package* is designed to address the training needs of the live performance industry.

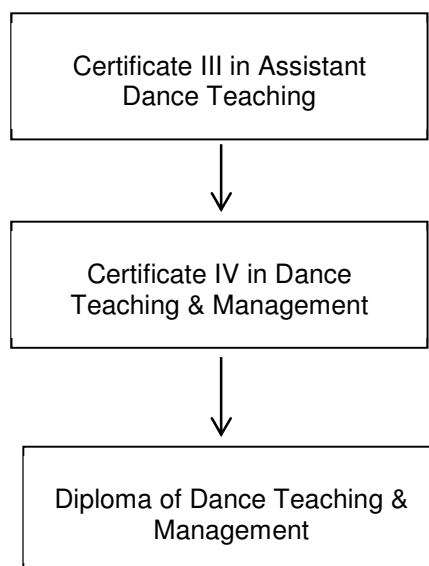
The range of qualifications covered by the training package is Certificate I to Advanced Diploma and provides comprehensive and integrated training for new entrants and existing workers.
